Minutes from the April 2, 2026 School Board Meeting

1. **Call to Order:** The meeting was called to order at 5pm by President, Chris Michienzi.
2. **Public Comment**
3. **Approval of Minutes:** A motion was made by Chris Michienzi and seconded by Sue Casey to approve the minutes from the March 9, 2026 School Board Meeting, all in favor.
4. **Financial Reports:**
WHEREAS, the financial reports have been presented by the Superintendent of Schools, and reviewed by the Board of Education;
THEREFORE, upon a motion by Jaime Parslow and seconded by Chris Michienzi, all in favor, the Treasurer's Report for February of 2026 is accepted; the financial reports for the period from March 1 through March 31, 2026 consisting of the appropriation and revenue status reports, the trial balance and the warrants have been reviewed; and
General Fund warrant number A-32 dated March 30, 2026 in the amount of \$26,830.99 and General Fund warrant number A-33 dated April 3, 2026 in the amount of \$14,644.89 are approved for payment.
5. **Electrification of School Buses:** Polara Energy has been contracted, to do the study on the electrification of our school buses, through a grant from NYSERDA. They will be here in May to do a site visit.
6. **HFM BOCES:** April 29, 2026 is the date for the HFM BOCES vote on the Administrative Budget and the Election of 2 Board members.
7. **2026-27 Proposed Budget Review:** Richard Rose reviewed with the Board the proposed budget for the 2026-27 school year. A motion was made by Chris Michienzi and seconded by Sue Casey to approve the proposed budget in the amount of \$905,406, all in favor.
8. **Property Tax Report Card:** A motion was made by Chris Michienzi and seconded by Jaime Parslow to approve the Property Tax Report Card, all in favor.
9. **Tax Cap:** A motion was made by Chris Michienzi to approve the Tax Cap, all in favor.
10. **Letter to Residents:** Richard Rose reviewed with the Board his annual letter and budget summary. These are mailed to all residents, who are eligible to vote.
