1. **Call to Order:** The meeting was called to order at 6pm by President, Chris Michienzi.

3. **Approval of Minutes:** A motion was made by Chris Michienzi and seconded by Scott Pierce to accept the minutes from the November 12, 2020 Regular School Board Meeting.
4. **Financial Reports:**

WHEREAS, the financial reports have been presented by the Superintendent of Schools, and reviewed by the Board of Education;  
THEREFORE, upon a motion by Chris Michienzi and seconded by Sue Casey, all in favor, the Treasurer's Report for November 2020 is accepted; the financial reports for the period from November 1 through November 30, 2020, consisting of the appropriation and revenue status reports, the trial balance and the warrants have been reviewed; and General Fund warrant number A-16 dated November 13, 2020 in the amount of \$3,473.89, General Fund warrant number A-17 dated November 25, 2020 in the amount of \$19,717.14, General Fund warrant number A-19 dated December 11, 2020 in the amount of \$25,998.94, and Capital Fund warrant number HCR-1 dated December 11, 2020 in the amount of \$1,444.99 are approved for payment.
