Minutes from the June 18, 2026 School Board Meeting

- 1. Call to Order:** The meeting was called to order by President, Chris Michienzi.
- 2. Public Comment**
- 3. Approval of Minutes:** A motion was made by Chris Michienzi and seconded by Sue Casey to approve the minutes from the May 7, 2026 School Board Meeting and the May 7, 2026 Budget Hearing, all in favor.
- 4. Financial Reports:**
WHEREAS, the financial reports have been presented by the Superintendent of Schools, and reviewed by the Board of Education;
THEREFORE, upon a motion by Chris Michienzi and seconded by Sue Casey, all in favor, the Treasurer's Report for April of 2026 is accepted; the financial reports for the period from May 1 through May 31 consisting of the appropriation and revenue status reports, the trial balance and the warrants have been reviewed; and
General Fund warrant number A-39 dated May 15, 2026 in the amount of \$18,267.64,
General Fund warrant number A-40 dated May 29, 2026 in the amount of \$25,382.28 and
General Fund warrant number A-42 dated June 12, 2026 in the amount of \$20,861.85 are approved for payment.
- 5. Transfers:** A motion was made by Chris Michienzi and seconded by Sue Casey to approve the transfers, all in favor.

- 6. Lease Agreement with Town of Arietta:** A motion was made by Chris Michienzi and seconded by Sue Casey to approve the Lease Agreement with the Town of Arietta, this agreement is from May 2026 to May of 2031, all in favor.
- 7. Certify Budget Vote and Board Election:** A motion was made by Chris Michienzi and seconded by Sue Casey to certify the results of the 2026-27 Budget Vote and the Board Election, all in favor. The budget was passed by a vote of 34 to 1 and Sue Casey was re-elected to the School Board until June 30, 2029.

9. **Student Enrollment:** Richard Rose reviewed with the Board the enrollment projections for the 2026-27 school year.

11. **HFM BOCES Commitment:** A motion was made by Chris Michienzi and seconded by Sue Casey to approve the HFM BOCES Services Commitment for 2026-27, all in favor.
12. **Septic System:** A discussion was had regarding the need to have our septic system inspected and consider having to have some replacement work done.

16. **Health Insurance:** A motion was made by Chris Michienzi and seconded by Sue Casey to increase the District contribution for Health Insurance to 95%, for Jennifer Phelan and Scott Chevalier, all in favor.
17. **Adjourn:** A motion was made by Sue Casey and seconded by Chris Michienzi to adjourn, all in favor.
